## **Officer On Duty**

Hello. I hope that everyone is doing well. I have been busy working on speed enforcement and a few burglaries in the Canal Park area. As some of you may have noticed, I have been steadily issuing citations for parking and some for speeding. Also, the Duluth Police Department has taken many reports of vehicles being stolen in the city. Some people like to warm up there cars during the winter season by leaving their keys in the ignition. This is a great opportunity for car thieves to strike even if it is in your driveway. Please remember, it is against the law to do this on the public street. Below, you will find the city ordinance covering this issue. If you have any questions, please contact me at 390-2863.

Sec. 33-91. Keys to be removed from unattended vehicles.

No person shall leave a motor vehicle, except a truck which is engaged in loading or unloading, unattended on any street, alley, used car lot or unattended parking lot without first stopping the engine, locking the ignition and removing all ignition keys from the vehicle; provided, however, that any violation of these provisions shall not mitigate the offense of stealing such motor vehicle, nor shall such violation be used to effect a recovery in any civil action for theft of such motor vehicle, or the insurance thereon, or have any other bearing in any civil action.

Whenever any police officer of the city shall find any such motor vehicle standing in violation of the foregoing provisions, such police officer is authorized and directed to remove there from the keys left therein and to deliver the same to the officer in charge at police headquarters. (Ord. No. 6838, 6-12-1950, § 68; Ord. No. 7049; Ord. No. 7265, § 1.)

## **Park Point Community Club Minutes of the Meeting: November 17, 2005**

Stinging wind pushed the first icy snow crystals of the season into the faces of hardy Club members as they gathered this night. Gradually a quorum was reached; the meeting was called to order at 7:15 pm. Minutes of the October meeting were approved despite peculiarities and chocolate fingerprint smudges.

### **Committee Reports**

**President:** As the quorum was reached, Dick Gould spoke off-the-cuff about different problems he had been attending to as Club President, and issues that stand as priorities for the Point in the future. This informal President's Report opened the meeting.

Sales of the cookbook have been exceptional. 1500 have been sold; the remaining 200 will be gone soon, as holiday shopping picks up.... The confusion from Duluth City Hall (discussed at length in October's meeting) continues to plague us. During last month's meeting, a formal vote was taken to cancel payment on a Club check written to Duluth's Legacy Fund that had been lost by the City. The check has not been found, but the Club DID receive a thank-you note for it.... Park Point residents are encouraged to decorate for this year's holidays. There is a strong chance NBC will be here to give national exposure to Marcia Hales' lights display.... Action against rising property taxes should be an issue embraced by the Club before more of our fixed-income residents are forced by economics to sell and move away.... An Art Fair committee meeting was held on November 10. The profit goal for the 2006 Art Fair is \$8500.

**Treasury:** Chuck Flaig noted that all Club debts were paid and all expenses current; club treasury stands at over \$44,000.

**Environmental:** Dave Johnson, tonight wearing his favorite pair of footie-pajamas (the ones with pirates on them) rambled briefly about the S-curve project. One city official had suggested flattening the big dune and doubling the size of the existing parking lot. This idea was nipped before budding. Dick Gould noted that a well would not be allowed at the site; sand-point wells are illegal in the city limits.

**City Liaison:** Cliff Tchida analyzed the outcome of the City Council elections; it seems likely that the Council will still produce decisions based on a 5-4 split.

**Police:** Officer Mike Tinsley passed out his latest statistics report, then he clarified a few laws Park Pointers are prone to break, such as jumping the red light when the bridge comes down. Members in attendance batted their wide, honest eyes at the thought of such vulgar hooliganism.

**Art Fair:** The Club briefly returned to the topic of the 2006 Art Fair, with more details about the November committee meeting. Ideas include expanding the fair by 10-20 more artists, a skywalk banner and a sponsored shuttle-bus.

**Old Business:** At the October meeting, motions were passed to: 1) Donate \$200 to the annual CHUM Christmas Party through Muggs McGillis; and 2) Approve a contribution not to exceed \$2000 for boardwalk construction projects at the Barrens. Club bylaws require a second vote on major expenditures. Dick Gould called for this second vote; both passed with unanimous "ayes" (one "aye matey").

**New Business:** Dick Gould underscored that he isn't interested in pursuing another term as President when his current term expires. The Club needs to think about a slate of officers beginning with the January meeting.... The Comprehensive Plan component involving street ends has "faded to a halt".... A discussion about beach access at night brought the Club meeting to its finish at 7:53.

### War Department says no to Park Point to Superior rail line.

The wish of Park Pointers to have a shortcut to and from Superior probably began as soon as this peninsula was occupied. For a brief time, it appeared the concept might actually become a reality. In his book, History of Duluth and St. Louis County, Dwight Woodbridge explained why the idea was permanently abandoned.

"A sudden craze sprang up during the months of May and June of 1883 to build railroads to connect Minnesota Point with Rice's Point on the line of the old dike. The Lake Superior Railroad Company, the Duluth and Northwestern Railroad Company, the Duluth Transfer and Dock Company and the Duluth, North Shore and Southwestern Railroad Company were started simultaneously and all four roads were clamorously demanding the right of way that was supposed to exist along the line of the old dike.

Meeting after meeting of the village council was held, but the whole four schemes were blown up one fine morning by the reception of a telegram from the War Department informing the people of Duluth that if they wanted anymore channels dug in their harbor, to give up the idea of crossing them with bridges or other obstructions to navigation.

The (War) Department would not ask money from congress to deepen the harbor unless it was to be free and unobstructed. This alternative put an end forever to these railroad schemes."

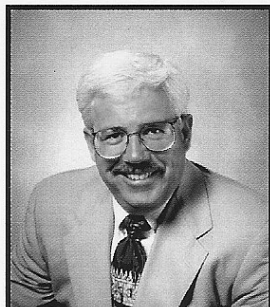
