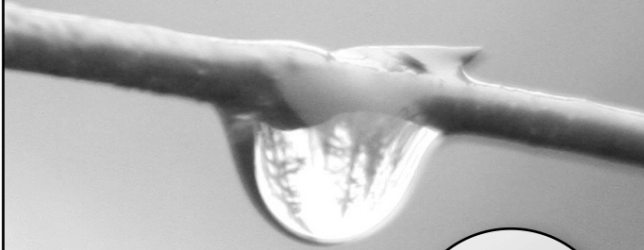

June 17, 2010

President Richard Gould called the meeting to order, 7:00pm.

MSC Motion to accept meeting minutes from May 20th meeting.

Dick Gould asked for the keys for Lafayette be returned.

Treasurer's Report. Chuck Flaig reported beginning balance of \$45,491.46. Expenses were \$7,306.87. Deposits were \$25,615.32. Ending balance as of 5/31/10 was \$63,799.91.

Sunshine Committee. Pam Griggs spoke about cards the Sunshine Committee could send out upon request.

Art Fair Committee. Carla Tamburro gave an update KUND and Playlist coverage on the art fair. From interviewing artists to showing old pictures of the art fair back 40 years. The Reader also ran a free ad for the Art Fair. United Health Care advertised for the event by mailing 3000 people. The format for the Art Fair guide was changed to include a map.

Breeze. Alan Dartanyan because of the amount of information needed to go in the Breeze would decrease font size. He also said there would be an ice cream social for the August, 2010 meeting.

Environmental Committee – Kinnan Stauber said the Marshall students she had lined up to do volunteer work had completed their assignments.

Flags would be spaced along Park Point beach to show rip current. 500 trees were planted. There was no official report on the garage sale but those in attendance felt it went well.

Counselor Sharla Gardner spoke on the street assessment and the rate that will be assessed for the Minnesota Ave street improvement. Jim Benning from the City will be at the July, 2010 meeting to explain their position and how they arrived at the assessment fee. The mill and overlay project for Minnesota Ave. is tentatively scheduled for after Labor Day. Need a Parks and Rec. board member as Liz Makay is no longer on the board. It would be in the best interest of Park Point to have someone who understands the uniqueness of this area.

Joel Johnson did a rezoning request for the proposed motel. It was denied. It was suggested there would be an appeal by Joel.

There will be a meeting in the basement of Chester Creek Café Monday, June 21, 2010 @ 6:30 pm. Kinnan Stauber will be speaking. Camping on Park Point will be discussed along with the Sky Harbor Airport issues.

Keith Stauber said there was an opening on the Franciscan Advisory Board. He explained why it would also be beneficial to have a community representative on the board.

Officer Mike Tinsley. Told about the speed monitoring device on the Point, vandalism on the Point and on the sailboats at the end of the Point. He spoke about camping on the end of Park Point. The challenges of being able to get emergency help to these people, etc. Did not have the exact figures but said there are usually more calls for the police in the summer and those calls usually drop off in September.

Friends of the Parks. Leanne Rutherford said on Friday @ 10:00 am, there would be volunteers to clean up the beach.

Joy, the director of the Summer Youth Program asked for more money. \$3800 to \$5000. To help offset this expense, the program was going to raise fees from \$40 to \$75 per participant. In the event there were more than one person from a family attending, the remaining attendees would pay \$15 each. MSC Motion to increase Joy's contract amount.

S-Curve Gardening. Lynn Bentfield said on Tuesday @ 7:00pm, there would be a meeting to discuss possibility of decorating the S curve.

Kinnan Stauber gave updates on where the park begins at the end of the Point. Kinnan would like to hire an attorney for an opinion. Motion was made to #1 – authorization for a couple of hours and #2 – authorization for up to \$5000 which would take executive board approval. The motion was seconded and then accepted.

Keith reminded the club that in July, there would be 350 competitors for the Duluth Rowing Club. He invited us to come to the event.

MSC Motion to adjourn meeting @ 9:15pm. Motion was seconded and accepted.

News from the Lafayette Community Edible Garden

June found us nibbling at our first garden greens at our potluck Salad Bar Dinner on the 22nd. Entertaining and educating us that evening was Dr. Dave Worley, who told us about the joys and labors of being a beekeeper. Our Children's Garden committee introduced the programs they will be presenting to the kids enrolled in the summer program at Lafayette Square, the first of which will be a watermelon tasting and seed planting on June 28th.

Visitors are welcome to see what's growing in the garden at Lafayette Square. It's a great learning tool to help you decide what you might want to plant in your home garden. You'll see tomato plants growing in plastic swimming pools, a hay-bale container garden, extremely efficient large compost bins, and beneficial companion plantings in many beds. Please remember: only members are allowed to harvest the crops.

New hotel planned for Park Point requires rezoning and will have major impact on our neighborhood

At the May Community Club meeting, Troy Hoekstra from Cornerstone Construction of Saint Cloud and Joel Johnson of Lakehead Boat Basin presented their plans for the Lakehead Marina Hotel on Park Point. It will be a large 53-unit, four-story hotel to be built on Lake Avenue between 10th and 11th Streets. Mr. Hoekstra mentioned discussions with representatives of chain restaurants for inclusion in the project. Mr. Johnson also mentioned a possible hotel expansion onto his adjacent property currently housing the Halvorson Inc. engine repair shop. If built, this hotel will have a major impact on all Park Point residents.

This projects requires a significant rezoning of Park Point property to move forward. Currently, the Lake Ave. stretch of 10th to 11th streets is a residential neighborhood of century-old single-family homes, duplexes and four-plexes, and zoned R2 (two family residential). The 10th to 11th streets stretch along Minnesota Ave.—across from Lakehead Boat Basin— is zoned M1 (manufacturing). Neither of these allow a hotel. The new City of Duluth comprehensive plan and the soon-to-be-adopted Unified Development code calls for "traditional neighborhood" zoning on the entire parcel. Traditional neighborhood zoning also would not allow this hotel. A hotel of this size dramatically changes our neighborhood, for the worse. Once built, we've lost our residential neighborhood forever.

The developer has suggested the hotel might include a convenience store. While Park Point residents may like the idea of a store to replace Bayside Market, this is only a suggestion by the developer, not a firm promise. Likewise, with the proposed rezoning, the developers could build a 120-foot high hotel. Just because they describe one plan doesn't mean that's what they'll actually do.

There are huge concerns by Park Point residents about this project. Our single-lane road, especially between the bridge and S-curve, is heavily burdened by traffic from recreationalists, Lift Bridge backups, Canal Park congestion, and many season events like the Art Fair, 4th of July, etc. Studies show that, on average, ONE hotel room generates 10 vehicles trips per day. This hotel project is planning for 53 rooms.

If the Planning Commission and City Council approve this rezoning request, it would set a precedent for other properties to be rezoned the same way up and down Park Point.

Hotel developers claimed, during the PPCC meeting, that the project would lead to increased property values. Seriously? It's very difficult to imagine someone buying a family home 20 or 300 feet from a towering 4-story hotel. Would YOU buy a home next to constant car traffic, noise from guests partying on their balconies, 24/7 light pollution from parking lots and entrances, and the shouting from a rooftop sport court? Aside from the property value question, there is no doubt that all residents near this development will experience the loss of quality of life with a hotel smack-dab in the middle of their residential neighborhood.

A project like this has City-wide consequences, as well. Where will these added tourists access the beach, which they'll see out their windows and balconies? The 12th Street beach access is already highly used by Duluth residents. Will the City then develop the 12th Street beach access with toilets, garbage service, and a larger parking lot to accommodate the extra hotel guests? Will the City patrol and stop the extra noise and beach activity in this zone after 10PM? Or will this be left to Park Pointers, once again, to deal with? What about the increased demand on aging infrastructure from a 53-unit hotel?

There are so many concerns to address when rezoning Park Point to facilitate growth like this. These are just a few. These concerns must be addressed by our government officials. Please get involved and voice your concerns on Park Point rezoning by contacting the City Council immediately. By the time you read this, the Planning Commission will have voted on this rezoning (they meet June 8) and it will be turned over to the City Councilors for approval or denial. The Council may have this proposal on their agenda for June 28 session for the required first reading, then it may be voted on at the July 12 meeting following a second reading. At this point, these are best-guess dates.

Sharla Gardner is our Park Point Councilor, and is already aware of this hotel rezoning proposal. While she is our district representative, all the councilors will vote on this and are responsible to your concerns.
