Welcome and introduction to the purpose of the meeting and background information (handouts provided, i.e. Attorney General opinion, Maritime Law, law re. community right to maintain present community context)

Step 2. (30 minutes)

Please come prepared with your answers to the following questions! Participants are asked to write their comments on the sheet, which they will turn in at the end of the meeting.

Each question will be discussed for 10 minutes each. Up to 10 participants may express their comments and they are asked to raise their hands to speak - each person will have 1 minute to share briefly their views.

a. What do like about living on Park Point (what is your most important/best example)?

b. What is your most important immediate concern about land utilization on Park Point?

c. What do you want Park Point to look like ten years from now?

Step 3. (5 minutes)

a. Please turn in you comment sheets.

b. Next steps: form a Park Point task force which will determine a process for continuing the discussion and develop a collective vision for our neighborhood, based on input from our residents; take names of people who want to volunteer to be on the task force, which will meet before the next PPCC monthly meeting and present their plan for moving forward.

Note:

If there is a need for more discussion, there may be a 2nd special meeting before the task force is formed.



We met on the 27th at the Iron Mug Cafe in Morgan Park. What a great group of passionate & thoughtful Duluthians.



Lafayette Community Edible Garden News

September is upon us and it's harvest time. In August, we harvested garlic. Pulling the bulbs out of the ground is just the start: they can be eaten right away or tied together with string and left to hang for 3 to 6 weeks in order to cure for better storage. Some of the bulbs will be used to propagate next year's crop by planting them this fall.





Growing garlic is very easy and can be done in a sunny spot in your garden or even in containers (they need a pot that is at least 18" deep and 12" wide and has drain holes). Break a garlic head apart and plant only the largest cloves about 3" deep with the flat side down and the pointy side up. The tip of the clove should be about 1" below the soil surface. Cover with a little straw to protect the plants from winter's cold and then remove the straw when the temperatures warm in the spring and watch the sprouts shoot skyward.

Perhaps you have noticed the beautiful red flowers along the garden fence that faces the street. Those are the scarlet red runner bean flowers. We are looking forward to harvesting these beans and using them in dishes for the big city-wide potluck on October 24th, which will showcase beans, the Duluth Community Garden Program's Vegetable of the Year.

Flowers envelope this Dutch Colonial home built in 1909 for William (general manager of the Great Northern Power Company) and Martha Ryerson, both of Dutch descent. It is the only known Duluth house designed by renowned Minneapolis architect Edwin A. Hewitt. The house was sold to Adam G. and Clara Thompson in 1918. A member of Duluth's Board of Trade, A.G. ran his father's firm which operated Superior's Great Northern grain elevators. The home now serves as a bed and breakfast. Dear Commissioner Jewell,

The Duluth City Council recently acted on the sale of County Tax Forfeit Land between 13th and 15th Streets on St. Louis Avenue in the City of Duluth on Park Point.

The Duluth Boat Club (DBC) holds a lease on the property across St. Louis Avenue from the land identified in the previous paragraph. It is our understanding that a meeting between the neighbors and the City was held to explain the proposed council action. The DBC was not informed of or given opportunity to comment on this action.

The DBC arranged for the purchase of the former Naval Reserve site, now under lease to DBC, by the City of Duluth using Sea Grant money and approximately \$50,000.00 of City capital. This was a genuine bargain for all involved. This lease is currently being updated.

A proposal to gift the aforementioned county tax forfeit land to the city for inclusion in the recreational area was in process through then Commissioner Fink but was held back because of mistrust between neighbors and the city.

The Duluth boat Club believes the tax forfeit land has the potential to provide a needed buffer between the resident neighbors' property and the recreational area.

For the purpose of getting everyone involved, on the same page and doing what is best for all concerned we would ask that a meeting of County, City, Duluth Boat Club and Neighbors be advertised and held prior to listing or selling the property to the highest bidder.

Our contact information is included for your convenience and it is our desire to hear from you in the near future.

Still Time Left for September Swimming!

Here are some sample water temperatures from recent weeks: 7/10 - 68 degrees

- 7/12 56 " (west wind)
- 7/17 54
- 7/18 68 (14 degrees in a day!
-switch to a strong E. wind)
- 7/28 68
- 7/30 60 (wind back to west)
- 8/1 70 (ten degrees in 24 hours! First 70 degree reading of the season)
- 8/4 8/19 temps consistently in the 70's, w/ east winds off the Lake 8/10 - Season high: 75 degrees

Moral of the story: Don't let the weather people chase you off the beach! West winds mean cool water, no matter how hot the air temperature; several days of east winds make the nicest swimming conditions, so long as you stay wary of rip currents.

[All temperature readings taken near Lafayette Community Center at a depth of 16" below the surface, approximately 30 yards from shore.]

Park Point......Naturally

There are not many news stories these days that lift one's spirits. A recent report on the future of the official Scientific and Natural Areas on the Point was a wonderful public response to a DNR query. A majority opted for limiting human intrusions. Though some dog owners may object, these pets will have to be restrained by a leash to keep them from harming wildlife living in this safe habitat.

It's hard to imagine that anyone would listen seriously to a counter argument of this being another example of the government "locking up the land." It's my hope that periodic reports on official studies of the two-part, 18-acre special areas will be available to the public. I, for one, want to hear more about the uniqueness of the plants and animals thriving in this preserved and protected habitat amid the lush growth of the white and red pines.

I guess I could be charged with being a naturally born "tree hugger." Throughout my many years, I have developed a warm, protective feeling for certain specific ones. Right now, I fear windstorms this fall will tip two of them into the harbor. I eye them daily from my apartment---a black spruce and a deciduous species. They stand...or should I say lean...precariously close to the water. Daily the waves are lapping at their exposed roots.

As I had mentioned in past issues of the Breeze, I watch birds, mostly the over-wintering crows, seek refuge from the frigid north winds by squeezing in between the branches of the spruce to snuggle up to the trunk of the tree.

When I moved into my apartment at the foot of 19th fourteen years ago, the waterfront had a great stretch of sand beach three or four feet wide in some places. The recent rise in the level of the bay has obliterated that feature. Erosion, I'm hearing, has been eating away at the real estate in many spots on the Point.

An opposite problem, too little depth in the harbor, made the shipping industry very unhappy. The ore carriers were forced to take on less tonnage to keep from running aground. Nature simply can't be all things to all people with special interests.

In reflecting on my (unscientific) observations of waterfowl this summer, I remain concerned about the small numbers of geese, mallards, mergansers, bluebills and shorebirds seen routinely in previous years. I didn't see a single blue heron or a kingfisher! I hope you had better luck.
